

**ORDINANCE NO. 2015-6**

**ORDINANCE OF THE BOROUGH OF RED BANK,  
COUNTY OF MONMOUTH, NEW JERSEY  
AMENDING AND SUPPLEMENTING  
CHAPTER VIII, “PARKING LOTS AND HANDICAPPED PARKING SPACES”  
SCHEDULE II, PERMIT PARKING ZONES**

Councilman Murphy offered the following ordinance on final reading and moved its adoption:

**WHEREAS** the Borough of Red Bank no longer has jurisdiction over the area known as “The Great Swamp Lot” and there is a need to remove this property from the Permit Parking Schedule;

**NOW THEREFORE, BE IT ORDAINED** by the Governing Body of the Borough of Red Bank that Chapter VIII of the Revised General Ordinances of the Borough of Red Bank, Monmouth County, “Parking Lots and Handicapped Parking Spaces,” Schedule II “Permit Parking Zones”, is hereby amended as follows:

**SECTION ONE:** Schedule II, Permit Parking Zones of the Revised General Ordinances of the Borough of Red Bank, is hereby amended as follows (stricken text denote deletions, underlined text denote additions):

**SCHEDULE II  
PERMIT PARKING ZONES**

In accordance with the provisions of Subsection 8-2.6 no person shall park between the hours specified in ~~any of~~ the following described locations unless he/she has purchased a permit parking identification card for a specific lot that can only be used in that specific lot and that the parking identification card shall be same is prominently displayed on the rear view mirror or front dashboard of his vehicle in such a manner as to permit close examination by a parking enforcement officer, Metered parking shall be permitted in the following permit spaces after 2:00 p.m. on the days indicated.

White Street Lot	8am – 6pm Monday – Friday	All or part of Block 31, Lot 2.01, as shown on the Borough of Red Bank tax records as may be designated by resolution of the Mayor and Council from time to time.
Gold Street Lot	8am – 6pm Monday – Friday	All or part of Block 46, Lots 3 and 4, as shown on the Borough of Red Bank tax records as may be designated by resolution of the Mayor and Council from time to time.
Great Swamp Lot	<del>8am – 6pm Monday – Friday</del>	<del>All or part of Block 29, Lots 3, 32.01, 31, 30, 29 and the rear side portion of Lots 4 and 25.01, as shown on the Borough of Red Bank tax records as may be designated by resolution of the Mayor and Council from time to time.</del>
Mechanic Street And Linden Place	8am – 6pm Monday – Friday	Area bounded on the north side by Mechanic Street, on the south side by Linden Place, on the east side by Lots 10 and 20 in Block 29 and Lots 9 and 32 in Block 48 as shown on the Borough of Red Bank Map and on the west side by Lots 7 and 23 in Block 29 and Lots 6 and 36 in Block 48 as shown on the Borough of Red Bank Tax Map.

Globe Court (This parking facility is leased to the Riverview Medical Center with limited reservation of parking spaces for the Borough.)	8am – 6pm Monday – Saturday	All or part of Block 7, Lot 1.01, as shown on the Borough of Red Bank tax records as designated by resolution of the Mayor and Council from time to time.
Morford Place	8am – 6pm Monday – Saturday	Northerly end of Morford Place and close to Route 35 being west of Tax Block 4.01, Lot 24 and Lot 25.01. Eleven (11) parking spaces are in an area 93.5± feet long on the easterly side of the property toward Route 35; two (2) parking spaces being 17± feet wide are located at the northerly end of the property just north of the access drive from U.S. Route 35 into Lot 25.01.
Union Street	8am – 6pm Monday – Friday	Between Oakley Lane and Boat Club Court.

**SECTION TWO:** Any ordinances or portions thereof which are inconsistent with the provisions of this Ordinance are hereby repealed as of the effective date of this Ordinance.

**SECTION THREE:** If any provision of this Ordinance or the application of such provision to any person or circumstance is declared invalid, such invalidity shall not affect the other provisions or applications of this Ordinance which can be given effect, and to this end, the provisions of this Ordinance are declared to be severable.

**SECTION FOUR:** This Ordinance shall take effect immediately upon its passage and adoption according to law.
