

ORDINANCE NO. 2014-6

ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER VII, "TRAFFIC", SECTION 7-3.10
"PARKING PROHIBITED ON CERTAIN STREETS DURING SNOW EMERGENCY" OF THE
REVISED GENERAL ORDINANCES OF THE BOROUGH OF RED BANK

Councilman DuPont offered the following ordinance and moved its adoption on final reading:

BE IT ORDAINED by the Governing Body of the Borough of Red Bank that Chapter VII,
"Traffic", Section 7-3.10 "Parking Prohibited on Certain Streets During Snow Emergency" of the
Revised General Ordinances of the Borough of Red Bank, be amended and supplemented as follows:

SECTION ONE: Section 7-3.10 "Parking Prohibited on Certain Streets During Snow
Emergency" of Article VII ("Traffic") of the Revised General Ordinances of the Borough of Red Bank
is amended and supplemented as follows (stricken text denotes deletions, underlined text denotes
additions):

§ 7-3.10 Parking Prohibited on ~~Certain~~ Streets During Snow Emergency.

- a. Whenever snow has fallen and the accumulation is such that it covers the street or highway, an emergency shall exist and no vehicle shall be parked on any Borough street between 11:00 pm and 7:00 am. ~~No person shall allow or permit a vehicle a vehicle to be parked upon any street , or parts of a street, while the road is covered with snow, which streets are designated in schedule XXI attached and made a part of this Chapter.~~
- b. Any Vehicle parked in violation of this section shall be deemed a nuisance and a menace to public safety and any public safety officer may provide for the removal of such vehicle. The owner shall pay the reasonable costs of removal and storage of the vehicle before regaining possession thereof.
- c. This parking prohibition shall remain in effect until after the snow has ceased and until the streets have been sufficiently plowed and cleared of snow for the full width as well as until parking and to the extent that parking will not interfere with the normal flow of traffic or impede the passage of emergency vehicles.
- d. During a snow emergency, as defined in this ordinance, owners, tenants, and/or their agents shall be prohibited from plowing or otherwise depositing snow onto Borough streets.

SECTION TWO: Any ordinances or portions thereof which are inconsistent with the provisions of this Ordinance are hereby repealed as of the effective date of this Ordinance.

SECTION THREE: If any provision of this Ordinance or the application of such provision to any person or circumstance is declared invalid, such invalidity shall not affect the other provisions or applications of this Ordinance which can be given effect, and to this end, the provisions of this Ordinance are declared to be severable.

SECTION FOUR: This Ordinance shall take effect immediately upon its passage and adoption according to law.
