

ORDINANCE NO. 2011-10

ORDINANCE OF THE BOROUGH OF RED BANK,  
COUNTY OF MONMOUTH, NEW JERSEY  
AMENDING AND SUPPLEMENTING  
CHAPTER VIII, "PARKING LOTS AND HANDICAPPED PARKING SPACES"  
SECTIONS 8-2.4, "OPERATION OF PARKING METERS" AND  
8-2.5, "PARKING TIME LIMITS"  
SCHEDULE I

WHEREAS, the Maple Avenue Parking Lot has been previously used as a permit parking lot; and

WHEREAS, the Governing Body of the Borough of Red Bank has determined that it is in the best interest of the Borough to make the Maple Avenue Parking Lot more accessible to the public by designating it as a metered lot to be included in the Borough's Parking Meter Zones;

NOW, THEREFORE, BE IT ORDAINED by the Governing Body of the Borough of Red Bank that Chapter VIII of the Revised General Ordinances of the Borough of Red Bank, Monmouth County, "Parking Lots and Handicapped Parking Spaces," Sections 8-2.4, "Operation of Parking Meters" and 8-2.5, "Parking Time Limits" Schedule I, are hereby amended as follows:

SECTION ONE: Schedule I to Sections 8-2.4, "Operation of Parking Meters" and 8-2.5, "Parking Time Limits" of the Revised General Ordinances of the Borough of Red Bank, is hereby amended as follows (stricken text denote deletions, underlined text denote additions):

SCHEDULE I

PARKING METER ZONES

In accordance with the provisions of Subsection 8-2.4 and 8-2.5 no person shall park between the hours specified in any of the following described locations unless they place the proper amount of money in the parking meter.

SECTION TWO: Any ordinances or portions thereof which are inconsistent with the provisions of this Ordinance are hereby repealed as of the effective date of this Ordinance.

SECTION THREE: If any provision of this Ordinance or the application of such provision to any person or circumstance is declared invalid, such invalidity shall not affect the

other provisions or applications of this Ordinance which can be given effect, and to this end, the provisions of this Ordinance are declared to be severable.

**SECTION FOUR:** This Ordinance shall take effect meter installation.
