**ORDINANCE OF THE BOROUGH OF RED BANK,
COUNTY OF MONMOUTH, NEW JERSEY
AMENDING AND SUPPLEMENTING
CHAPTER VII, "TRAFFIC,"**

SECTION 7-3.3, "PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS"

SCHEDULE I, "NO PARKING"; and

**SECTION 7-3.6, "PARKING TIME LIMITED ON CERTAIN STREETS,"
SCHEDULE IV, "TIME LIMITED PARKING"**

WHEREAS, cars parked along Oakley Lane block ingress and egress to the residential building located in that vicinity, creating a hazardous condition and blocking the provision of municipal services in that vicinity;

NOW BE IT ORDAINED by the Governing Body of the Borough of Red Bank that Chapter VII of the Revised General Ordinances of the Borough of Red Bank, Monmouth County, "TRAFFIC," Section 7-3.6, "Parking Time Limited on Certain Streets," and Schedule IV thereto, "Time Limited Parking;" as well as Section 7-3.3, "Parking Prohibited at All Times on Certain Streets," and Schedule I thereto, "No Parking" are hereby amended and supplemented as follows:

SECTION ONE:

a. Section 7-3.3, "Parking Prohibited at All Times on Certain Streets" and Schedule I thereto, are amended and supplemented as follows:

7-3.6 Parking Time Limited on Certain Streets.

No person shall park a vehicle at any time upon any of the streets or parts thereof described in Schedule I attached to and made part of this Chapter.

Schedule I, "No Parking," is amended and supplemented as follows: (*strikeouts denote deletions, underlined text denotes additions*):

SCHEDULE I

No Parking

In accordance with the provisions of Subsection 7-3.3, no person shall park a vehicle at any time upon any of the following described streets or parts of streets.

Name of Street	Side	Location
Oakley Lane	<u>West</u> <u>Both</u>	From West Front Street to Union Street.

b. Section 7-3.6, "Parking Time Limited on Certain Streets" and Schedule IV thereto, are amended and supplemented as follows: (*strikeouts denote deletions, underlined text denote additions*):

7-3.6 Parking Time Limited on Certain Streets.

No person shall park a vehicle for longer than two (2) hours between the hours of 8:00 a.m. and 6:00 p.m. upon any street on any day (except Saturdays, Sundays and public holidays) within the Borough unless a different time limit or effective time period is set forth with respect to any of the streets, or parts of streets, described in Schedule IV attached to and made a part of this Chapter.

Schedule IV, "Time Limited Parking," is amended and supplemented as follows: (*strikeouts denote deletions, underlined text denote additions*):

SCHEDULE IV
TIME LIMITED PARKING

In accordance with the provisions of Subsection 7-3.6, no person shall park a vehicle for longer than the time limit shown on any of the following streets or parts of streets.

Name of Street	Side	Time Limit	Hours	Location
Oakley Lane	East	1 Hour	8:00 a.m. to 6:00 p.m.	Beginning at a point 38 feet north of Front Street and exiting north to a point 35 feet from Union Street.

[All other provisions remain unchanged]

SECTION TWO: Any ordinances or portions thereof which are inconsistent with the provisions of this Ordinance are hereby repealed as of the effective date of this Ordinance.

SECTION THREE: If any provision of this Ordinance or the application of such provision to any person or circumstance is declared invalid, such invalidity shall not affect the other provisions or applications of this Ordinance which can be given effect, and to this end, the provisions of this Ordinance are declared to be severable.

SECTION FOUR: This Ordinance shall take effect immediately upon its passage and adoption according to law.
