

**RESOLUTION NO. 17-127**

**A RESOLUTION OF THE BOROUGH OF RED BANK, COUNTY OF MONMOUTH,  
STATE OF NEW JERSEY, ACCEPTING PERFORMANCE GUARANTEE AND INSPECTION  
FEE POSTED BY SOUND STORAGE, LLC FOR BLOCK 75, LOT 114.01**

Councilman Zipprich offered the following resolution and moved its approval:

**WHEREAS**, pursuant to the Planning and Development Regulations of the Borough of Red Bank, County of Monmouth, State of New Jersey (the “Borough”), Sound Storage, LLC is required to post \$63,242.10 in the form of an acceptable performance bond, \$7,026.90 (10% in cash), and \$5,099.00 to serve as an inspection fee to secure the bonded improvements required in connection with the development of Block 75, Lot 114.01; and

**WHEREAS**, the Governing Body of the Borough has been advised by the Borough Planning and Zoning Department that a performance bond in the amount of \$63,242.10 has been issued by First Indemnity of America Insurance Company, 2740 Route 10 West, Suite 205, Morris Plains, New Jersey 07950, under Bond No. CT022758 for Block 75, Lot 114.01; and

**WHEREAS**, the Governing Body has been advised by the Borough Planning and Zoning Department that Sound Storage, LLC has posted a cash deposit in the amount of \$7,026.90 and tendered the amount of \$5,099.00 for inspection fees; and

**WHEREAS**, the acceptance of this performance guarantee is permitted, and in accordance with the provisions of the New Jersey Municipal Land Use Law and the Borough’s Planning and Development Regulations:

**NOW, THEREFORE, BE IT RESOLVED**, by the Governing Body of the Borough of Red Bank, County of Monmouth, State of New Jersey as follows:

1. That the Governing Body does hereby accept the performance bond in the amount of \$63,242.10, the cash deposit in the amount of \$7,026.90, and \$5,099.00 for inspection fees.
2. That a certified copy of this resolution be forwarded to the Chief Financial Officer, the Red Bank Planning Board, and Sound Storage, LLC.
