RESOLUTION NO. 17-137**

**A RESOLUTION ACCEPTING BID FROM AND AWARDING CONTRACT TO
GREENLEAF LANDSCAPE SYSTEMS AND SERVICES FOR THE 2017 PARK
MAINTENANCE CONTRACT**

Councilman Zipprich offered the following resolution and moved its adoption:

WHEREAS, after the required legal advertising was published, sealed bids were received on May 19, 2017 by the Borough of Red Bank in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for a Contract for Park Maintenance Services; and

WHEREAS, the Borough sought bids for a first year of the Contract from June 1, 2017 to December 31, 2017, and for renewal years at the Borough's option in 2018 and 2019; and

WHEREAS, the Borough Staff Engineer has recommended acceptance of the lowest responsive bid received from Green Leaf Landscaping Systems and Services consisting of Base Bid for "Riverside Gardens Park" at \$11,900.00; and

WHEREAS, the Borough Staff Engineer has also recommended accepting the bids for Add Alternate 1A "Marine Park" at \$7,210, Add Alternate 1C "East Side Park" at \$7,210, Add Alternate 1D "Count Basie park" at \$15,750, Add Alternate 1F "Triangle at Riverside Avenue, Front Street and Pearl Street" at \$1,260, Add Alternate 1H "Tower Hill Water Plant" at \$3,990, Add Alternate 1I "Red Bank Public Library" at \$5,600, and Add Alternate 1K "Newman Springs Lift Station" at \$140 with the total for both base bids and all Add Alternate bids with the exception of Add Alternate bids 1B, 1E, 1G, 1J, 1L, 1M, and 1N totaling \$53,060; and

WHEREAS, it is the desire of the governing body to award a contract for the 2017 Park Maintenance Contract to Green Leaf Landscaping Systems and Services for the Base Bid and Alternative Bids 1A, 1C, 1D, 1F, 1H, 1I, and 1K.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Red Bank that the above-described bid received from Green Leaf Landscaping Systems and Services for the 2017 Park Maintenance Contract is hereby accepted in accordance with the recommendation of the Borough Staff Engineer and subject to any necessary approvals by the County of Monmouth, or any other applicable governmental agency.

WHEREAS, said award is made pending certification of available funds by the Chief Financial Officer.

BE IT FURTHER RESOLVED that the Mayor and Clerk are authorized and requested to sign and deliver this contract on behalf of the Borough of Red Bank.

BE IT FURTHER RESOLVED that the Clerk forward a certified true copy of this resolution to Green Leaf Landscaping Systems and Services, 276 Pine Brook Road, Eatontown, NJ 07724; to the Borough Staff Engineer; and to the unsuccessful bidders.
