

**RESOLUTION NO. 17-211**

**A RESOLUTION OF THE BOROUGH OF RED BANK, COUNTY OF MONMOUTH,  
STATE OF NEW JERSEY REJECTING ALL BIDS RECEIVED FOR  
THE RIVER STREET RETAINING WALL PROJECT AND AUTHORIZING THE  
ADVERTISEMENT AND REBID OF THE PROJECT WITH REVISED SPECIFICATIONS**

Councilman Zipprich offered the following resolution and moved its approval:

**WHEREAS**, the Borough of Red Bank, County of Monmouth, State of New Jersey (the "Borough") authorized the receipt for bids for River Street Retaining Wall Project; and

**WHEREAS**, two (2) bids were received on August 15, 2017, in response to the aforementioned invitation to bidders; and

**WHEREAS**, said bids have been reviewed by the Borough Engineer and it has been determined that the lowest base bid substantially exceeds the Engineer's cost estimates for goods and services pursuant to N.J.S.A. 40A:11-132(a); and

**WHEREAS**, the Borough Engineer has recommended the rejection of all bids for the River Street Retaining Wall Project and the advertisement and rebid of the Project with revised specifications;

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Borough of Red Bank, County of Monmouth, State of New Jersey as follows:

1. That the governing body hereby rejects all bids received on August 15, 2017 for the River Street Retaining Wall Project.
2. That the governing body hereby authorizes the return of the respective bid securities remitted by the unsuccessful bidders pursuant to N.J.S.A. 40A:11-24.
3. That the governing body hereby authorizes the advertisement and rebid of the River Street Retaining Wall Project with revisions to the Project's specifications to indicate a maximum limit not to exceed for lump sum bid items.
4. That a certified copy of this resolution be forwarded to the Borough Administrator, Chief Financial Officer, Borough Engineer, and the unsuccessful bidders referenced herein.
