A RESOLUTION AUTHORIZING THE CREATIVE TEAM
AS A SUBCOMMITTEE OF THE GREEN TEAM

Councilman Zipprich offered the following resolution and moved its adoption:

BE IT RESOLVED that the Borough of Red Bank strives to save tax dollars, assure clean air and water, improve working and living environments to build a community that is sustainable economically, environmentally, and socially well into the next century; and

WHEREAS, the Borough of Red Bank wishes to build a model of government that benefits our residents now and far into the future with green community initiatives that are easy to replicate and affordable to implement; and

WHEREAS, the Borough of Red Bank has previously established a Creative Team as a subcommittee of the Environmental Commission and that Creative Team has recommended the establishment of a Creative Team to advance the concepts of creative place making and establish a vision for the community about how the art and culture can contribute to its future; and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Borough Council of the Borough of Red Bank that we do hereby reauthorize the Creative Team consisting of ten members who shall be a combination of residents or employees of the Borough of Red Bank and other individuals with strong ties to the Borough of Red Bank, appointed annually, whose term of appointment shall be through December 31, 2017.
