

**RESOLUTION NO. 17-228**

**A RESOLUTION OF THE BOROUGH OF RED BANK, COUNTY OF MONMOUTH,  
STATE OF NEW JERSEY, AUTHORIZING TWO RIVERS WATER RECLAMATION  
AUTHORITY TO RELOCATE CHEMICAL INJECTION POINT TO THE  
BODMAN PLACE PUMP STATION**

Councilman Zipprich offered the following resolution and moved its approval:

**WHEREAS**, Two Rivers Water Reclamation Authority's Red Bank meter chamber has experienced odor and corrosion problems; and

**WHEREAS**, Two Rivers Water Reclamation Authority has received a recommendation from Evoqua, an odor and corrosion expert, to move the regional chemical injection point from the Red Bank meter chamber to the next available site upstream at the Bodman Place Pump Station; and

**WHEREAS**, the cost of chemical injected at the Bodman Place Pump Station would continue to be a regional expense of the Authority; and

**WHEREAS**, the relocation allows the use of nitrate oxygen, instead of hydrogen peroxide, which eliminates a site where a chemical that requires special hazardous precautions is used; and

**WHEREAS**, the injection of the nitrate oxygen (a longer acting and less hazardous chemical) at the Bodman Place Pump Station will provide enough time for the chemicals to react and protect the Red Bank meter chamber and the pipes downstream of the chamber after they have been rehabilitated; and

**WHEREAS**, the injection of nitrate oxygen at the Bodman Place Pump Station will also protect the Red Bank pipes between the Bodman Place Pump Station and the Red Bank meter chamber as some of those pipes were recently replaced by the Borough because of chemical corrosion similar to what has happened downstream of the meter chamber;

**NOW, THEREFORE, BE IT RESOLVED**, by the Governing Body of the Borough of Red Bank, County of Monmouth, State of New Jersey, that:

1. The Two Rivers Water Reclamation Authority is hereby authorized to relocate its chemical injection point from the Red Bank meter chamber to the Bodman Place Pump Station.
2. This resolution shall become effective immediately.
3. A certified copy of this Resolution shall be forwarded to the Two Waters Reclamation Authority, Borough Administrator, and the Borough Department of Public Utilities.
