

RESOLUTION NO. 17-229

**A RESOLUTION OF THE BOROUGH OF RED BANK, COUNTY OF MONMOUTH,
STATE OF NEW JERSEY, ESTABLISHING RED BANK JITNEY ROUTE NO. 1
WHOLLY WITHIN THE LIMITS OF THE MUNICIPALITY**

Councilman Whelan offered the following resolution and moved its approval:

WHEREAS, the Governing Body of the Borough of Red Bank has, by Ordinance, authorized the licensing and operation of jitneys within the Borough; and

WHEREAS, pursuant to said Ordinance and State law, the Governing Body is authorized and empowered to establish jitney routes wholly within the limits of the Borough;

NOW, THEREFORE, BE IT RESOLVED, that the Governing Body hereby authorizes and establishes the following Red Bank Jitney Route No. 1 within the Borough of Red Bank, for which interested parties may submit an application for a license to operate thereon subject to approval by the County of Monmouth:

- Originate at Bridge Avenue at Galleria heading South
- Left on Monmouth Street at Train Station
- Stop at Train Station on Monmouth Street
- Stop on Monmouth between Maple Ave. and Pearl St. (Count Basie Theater/Borough Hall)
- Continue on Monmouth Street
- Left onto Broad Street
- Stop on Broad between Mechanic St. and Front St. (Valet area)
- Right onto Front Street
- Left onto Wharf Avenue
- Stop at Wharf Avenue and Union Street
- Right onto Union through Riverview Plaza to Front Street
- Right on Front Street
- Left onto Broad Street
- Left onto White Street
- Stop in White Street Parking Lot
- Left onto Drummond Place
- Stop at Drummond Place and Monmouth Street
- Right onto Monmouth Street
- Right onto Pearl Street
- Left onto Wall Street
- Stop midblock between Pearl Street and West Street
- Left onto West Street
- Right onto Monmouth Street
- Right onto Bridge Avenue
- Stop at Bridge Avenue and Edmund Wilson Plaza
- Right onto Brower Place
- Stop at Brower Place and Morford Place
- Right onto Morford Place
- Right onto West Front Street
- Left into Galleria Parking Lot
