**RESOLUTION AUTHORIZING TAX APPEAL SETTLEMENT REGARDING
MARKS FAMILY LIMITED PARTNERSHIP, 63 RIVERSIDE AVENUE, BLOCK 5, LOT 8, RED
BANK, NEW JERSEY**

Councilman Yngstrom offered the following resolution and moved its adoption:

WHEREAS, the plaintiff, Marks Family Limited Partnership appealed to the Tax Court of the State of New Jersey under Docket Nos. 008535-2012; 003306-2013, 003774-2014, 008438-2016 and 008247-2016 pertaining to tax assessments for the 2012, 2013, 2014, 2016 and 2017 tax years on property designated on the municipal tax records as Block5, Lot 8, and with an address of 63 Riverside Avenue, Red Bank, New Jersey; and

WHEREAS, the Assessor and the Attorney have advised the Governing Body that they, along with the Borough’s valuation expert, have carefully considered the appeal and upon reviewing all the facts and based upon appropriate adjustments of fair market value that they recommend settlement providing for the settlement of the aforementioned appeals as follows:
