RESOLUTION AUTHORIZING AND APPROVING  
COLLECTIVE NEGOTIATION AGREEMENT BETWEEN  
THE BOROUGH OF RED BANK AND C.W.A. LOCAL #1075  
BLUE COLLAR & WHITE COLLAR/CLERICAL EMPLOYEES  
FOR THE YEARS 2017 THROUGH 2020

Councilman Taylor offered the following resolution and moved its adoption:

**WHEREAS**, the existing collective negotiation agreements between C.W.A. Communication Workers of America Local 1075 Blue Collar & White Collar Clerical, C.W.A. Communication Workers of America Supervisors (Local 1075) and the Borough of Red Bank (the Borough) have expired by their terms on December 31, 2016; and

**WHEREAS**, the Borough and Local 1075 have engaged in good faith negotiations on the terms of new agreements between the Borough and Local 1075; and

**WHEREAS**, subject to the approval of the Borough Council, the Borough and Local 1075 have agreed upon the terms and conditions of new collective negotiation agreements for the term commencing January 1, 2017 through December 31, 2020, as evidenced by Memorandum of Agreements between the parties; and

**WHEREAS**, the Mayor and Council of the Borough of Red Bank find that it is in the best interests of the Borough to approve and enter into the agreements as negotiated and agreed to by the parties.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Red Bank that it does hereby authorize and approve the agreements negotiated between Local 1075 and the Borough, which agreements shall be in effect for the years 2017 through 2020.

**BE IT FURTHER RESOLVED** that the Administrator is authorized and requested to sign the Memorandums of Agreement on behalf of the Borough pending the execution of new collective negotiations agreements, and the Administrator is further authorized and requested to sign the collective negotiations agreements on behalf of the Borough.

**BE IT FURTHER RESOLVED** that the Clerk forward a certified true copy of this resolution to the Administrator and all Department heads and to the President of the CWA 1075.
