**RESOLUTION NO. 16-06**

**A RESOLUTION AUTHORIZING 2016 TEMPORARY BUDGET**

Councilwoman Schwabenbauer offered the following resolution and moved its adoption:

**WHEREAS**, N.J.S. 40A:4-19 provides that where any contracts, commitments or payments are to be made prior to the final adoption of the 2016 budget, temporary appropriations should be made or the purposes and amounts required in the manner and time provided; and

**WHEREAS**, the date of this resolution is within the first thirty days of January 2016; and

**WHEREAS**, 26.25% of the total current fund appropriations in the 2015 budget exclusive of Debt Service, Capital Improvement Fund and Public Assistance is \$5,026,041.12.

**NOW, THEREFORE, BE IT RESOLVED** that the following temporary appropriations be made and that a certified copy of this resolution be transmitted to the Chief Financial Officer for her records.
