RESOLUTION NO. 15-83**

**RESOLUTION ACCEPTING BIDS FOR SUPPLY AND
DELIVERY FOR CERTAIN WATER PURIFICATION CHEMICALS**

Councilman DuPont offered the following resolution and moved its adoption:

WHEREAS, on March 24, 2015, bids were received for the supply and delivery for certain water purification chemicals, particularly: sodium hypochlorite, aluminum sulphate and hydrated lime; and

WHEREAS, these contracts included a base bid period of April 1, 2015 to December 15, 2015 and an optional renewal period of February 15, 2016 to November 15, 2016; and

WHEREAS, the Borough Engineer has recommended that the contract for the supply and delivery of Water Treatment Chemicals for sodium hypochlorite be awarded to Miracle Chemical Co., 1151 B Highway #33, in the total amount bid of \$35,820.00. Award of contract should be made subject to certification of availability of funds, review of the bid documents by the Borough Attorney and approval of the New Jersey Department of Labor, Division of Wage and Hour Compliance; and

WHEREAS, the Borough Engineer has further recommended the contract for the supply and delivery of Water Treatment Chemicals for aluminum sulphate (\$28,080.00) and hydrated lime (\$24,000.00) be awarded to Univar USA Inc., 532 E. Emaus St., Middletown, PA 17057, in the total amount bid of \$52,080.00. Award of contract should be made subject to certification of funds, review of the bid documents by the Borough Attorney and approval of the New Jersey Department of Labor, Division of Wage and Hour Compliance.

WHEREAS, the total yearly cost for both contracts is \$87,900.00 and funds are available for this purpose as certified by the Chief Financial Officer as demonstrated by the attached certification in account no(s). 5-05-55-501-246.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Red Bank that the above-described bids received from Miracle Chemical, Co. and Univar USA, Inc. for the supply and delivery for certain water purification chemicals is hereby accepted in accordance with the recommendation of the CFO and the Borough Engineer; and

BE IT FURTHER RESOLVED that the Mayor and Clerk are authorized and requested to sign and deliver this contract on behalf of the Borough of Red Bank; and

BE IT FURTHER RESOLVED that the Clerk forward a certified true copy of this resolution to Univar USA, Inc., to Miracle Chemical Co., to the Borough Engineer and to the unsuccessful bidders.
