RESOLUTION NO. 15-127**

**A RESOLUTION COMMENDING POLICE OFFICERS ASHON LOVICK,
JORGE TORRES AND SHANE DENGEL**

Councilman Zipprich offered the following resolution and moved its adoption:

WHEREAS, an emergency call was received on the morning of Sunday, April 26, 2015, regarding a man who had collapsed at City Center Plaza on Water Street; and

WHEREAS, the caller had advised that CPR was in progress and Patrolmen Ashon Lovick, Jorge Torres and Shane Dengel arrived to find Richard Moran suffering from a severe cardiac episode; and

WHEREAS, Mr. Moran’s condition worsened and his heart stopped beating and his breathing ceased. The Officers assessed Mr. Moran’s condition and worked in unison to administer CPR and delivered shocks via an Automatic Defibrillator, and

WHEREAS, the Officers were met on scene by MONOC EMT’s and paramedics and continued to perform CPR and deliver shocks via a defibrillator for over a half an hour; and

WHEREAS, Mr. Moran was finally revived for a final time in the MONOC ambulance prior to leaving the scene, and was transported to Riverview Medical Center; and

WHEREAS, Mr. Moran has since undergone surgery and is recovering well; and

WHEREAS, Mr. Moran’s survival and ultimate recovery can be directly attributed to the quick and decisive actions of the Officers and Emergency Medical personnel on scene; and

WHEREAS, as per Police Department Policy, Sergeant Robert Gannon has recommended that Patrolmen Ashon Lovick, Jorge Torres and Shane Dengel each receive a Life Saving Award for their efforts;

NOW, THEREFORE, BE IT RESOLVED that the Mayor and Council wish to commend Patrolmen Ashon Lovick, Jorge Torres and Shane Dengel for their exemplary actions and that we extend our appreciation on behalf of the entire community for their selfless acts of service to the people of Red Bank.

BE IT FURTHER RESOLVED that the Mayor and Council ask that a copy of this resolution be placed in their personnel files.
