RESOLUTION NO. 15-206

**A RESOLUTION ACCEPTING BID FROM AND
AWARDING CONTRACT TO DELISA DEMOLITION, INC. FOR
SOLID WASTE AND RECYCLING COLLECTION CONTRACT**

Councilman DuPont offered the following resolution and moved its adoption:

WHEREAS, after the required legal advertising was published, sealed bids were received on July 28, 2015 by the Borough of Red Bank in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for a Contract for Solid Waste and Recycling Collection and Disposal Services; and

WHEREAS, the Borough sought bids for a three year of contract from September 1, 2015 to August 31, 2018; and

WHEREAS, the Borough received five bids from:

1. Delisa Demolition, Inc., Tinton Falls, NJ;
2. Suburban Disposal, Fairfield, NJ;
3. M&S Waste Services, Middletown, NJ;
4. Republic Services, Tinton Falls, NJ;
5. Waste Management, Ewing, NJ and

WHEREAS, the Bids were reviewed and tabulated by the Borough Engineer; and

WHEREAS, Delisa Demolition was the apparent low bidder; and

WHEREAS, the Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq., provides that Borough must make an award to the lowest responsible and responsive bidder; and

WHEREAS, Delisa Demolition's total bid price is \$1,488,000.00 for a three year period (September 1, 2015 through August 31, 2018); and

WHEREAS, a certification of availability of funds has been provided by the Borough's Chief Financial Officer; and

WHEREAS, the Borough Attorney has reviewed the bids and finds that that bid of the Delisa Demolition is responsive and complies with all statutory requirements.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Red Bank that

1. the Contract for Solid Waste and Recycling Collection and Disposal is hereby awarded to Delisa Demolition, Inc. as the lowest responsible and responsive bid in an amount not to exceed \$1,488,000.00 (\$496,000.00 per year for three years); and
2. The Purchasing Agent is authorized to return the contract document fee and bid bonds to those qualified bidders who are entitled to a refund in accordance with the bid specifications; and
3. The Mayor and Clerk are authorized and requested to sign and deliver these contracts on behalf of the Borough of Red Bank.
