A RESOLUTION TO AWARD PAYMENT OF 2014 LOSAP BENEFITS TO ELIGIBLE MEMBERS OF THE RED BANK VOLUNTEER FIRE DEPARTMENT AND FIRST AID SQUAD

WHEREAS, a list of eligible members and proposed award has been reviewed and approved by the Chief Financial Officer and funds have been certified by the Chief Financial Officer; and

NOW, THEREFORE, BE IT RESOLVED that the Mayor and Council of the Borough of Red Bank, does hereby approve the list of Forty-Seven (47) eligible members to receive full benefits, One Thousand One Hundred Fifty Dollars and no cents (\$1,150.00) per eligible member, for a proposed total award of Fifty Four Thousand, Fifty Dollars and no cents (\$54,050.00) for 2014 LOSAP benefits, for eligible members of the Red Bank Volunteer Fire Department and First Aid Squad as annexed hereto and made a part hereof and authorizes payment in accordance therewith.
