**RESOLUTION NO. 15-221**

**RESOLUTION GRANTING REQUEST OF LOCUST LANDING  
URBAN RENEWAL FOR TEMPORARY RELIEF FROM TERMS OF PILOT  
AGREEMENT REGARDING CREDITS FOR PAYMENT OF LAND TAXES**

Councilman DuPont offered a motion to table the following resolution:

**WHEREAS**, Locust Landing Urban Renewal, L.P. ("Locust Landing") is a 40 unit tax credit apartment complex located at 105 Locust Avenue that provides housing for low to moderate income residents of the Borough of Red Bank; and

**WHEREAS**, Locust Landing and the Borough have entered into an Agreement dated February 9, 1999, pursuant to the provisions of the Long Term Tax Exemption Law, N.J.S.A. 40A:20-1 et seq., whereby Locust Landing was granted a long term tax exemption (the "PILOT Agreement"); and

**WHEREAS**, in lieu of the payment of property taxes on the improvements to the Property, the PILOT Agreement provides for the payment of an annual service charge as determined and calculated in the PILOT Agreement; and

**WHEREAS**, pursuant to the PILOT Agreement, the Land Taxes are not exempt; however, Land Taxes are applied as a credit against the Annual Service Charge; and

**WHEREAS**, pursuant to the PILOT Agreement, Locust Landing is obligated to make timely Land Tax payments in order to be entitled to the Land Tax Credit against the Annual Service Charge. In any year that Locust Landing fails to timely make any Land Tax Payment when due and owing, such delinquency shall render Locust Landing ineligible for any Land Tax Credits against the Annual Service Charge for that year; and

**WHEREAS**, Locust Landing was severely damaged and financially impacted by Hurricane Sandy in October of 2012; and

**WHEREAS**, as a result of Sandy, Locust Landing lost 16 units and sustained other infrastructure and utility damage that cost in excess of \$100,000 to repair; and

**WHEREAS**, Locust Landing failed to timely pay its Land Taxes in 2013 and 2014, which render it ineligible for the Land Tax Credit against the annual service charge for those years; however, Locust Landing is now current on its Land Tax payments and all Land Taxes for 2013 and 2014 have been paid; and

**WHEREAS**, by Resolution No. 14-242 adopted September 10, 2014, the Mayor and Council authorized the Land Tax Payments for 2013 and 2014 to be credited against the Annual Service Charge due for those years; and

**WHEREAS**, the Managing Agent has stated that Locust Landing is still impacted financially by the damage of Hurricane Sandy and has requested that the Mayor and Council allow Locust Landing's Land Tax Payments for 2014 to be applied to the PILOT calculation for the 2015 PILOT agreement; and

**WHEREAS**, the Mayor and Council find that given the extraordinary and difficult financial burdens occasioned by Hurricane Sandy as represented by Locust Landing's Managing Agent, that is fair, equitable and appropriate to grant Locust Landing a one-time exception from the

requirement that the Land Taxes be timely paid in order to receive the Land Tax Credit against the Annual Service Charge.

**NOW, THEREFORE, BE IT RESOLVED** that the Governing Body of the Borough of Red Bank hereby authorizes the Borough's Chief Financial Officer to apply the Land Tax Payments for 2014 as credit against the PILOT calculation for the 2015 PILOT agreement.

**BE IT FURTHER RESOLVED** that this one time exception granted by the Mayor and Council shall not be deemed a waiver of any of the Borough's rights and remedies under the PILOT Agreement in the event of a default by Locust Landing in any of the other terms or obligations thereof, and all terms of the PILOT shall remain in full force and effect notwithstanding this Resolution.

**BE IT FURTHER RESOLVED** that a certified copy of this Resolution be provided to the Borough's Chief Financial Officer and Locust Landing's Managing Agent.
