**RESOLUTION TO EXTEND THE CONTRACT WITH LAYNE CHRISTENSEN INC.  
FOR THE ROUTINE WELL AND BOOSTER PUMP INSPECTION AND MAINTENANCE  
AND EMERGENCY REPAIR SERVICES FOR WATER TREATMENT PLANTS,  
WELLS AND PUMPING EQUIPMENT**

Councilman Zipprich offered the following resolution and moved its adoption:

**WHEREAS**, on September 25, 2013, sealed bids were received for the Routine Well and Booster Pump Inspection and Maintenance and Emergency Repair Services Contract for Water Treatment Plants, Wells and Pumping Equipment; and

**WHEREAS**, Layne Christensen Inc. submitted the lowest responsible bid in the amount of \$158,720.00 and its bid was fully compliant with the specifications in all material aspects; and

**WHEREAS**, the contract documents state that the Borough may elect to extend the contract for a second renewal period of November 1, 2015 to October 31, 2016;

**WHEREAS**, Layne Christensen, Inc. has satisfactorily completed work included in Year One and in Year Two and the Borough Engineer recommends renewal for Year Three;

**WHEREAS**, the total costs for Year Three are \$49,948 and include the inspection and maintenance of Well #7 and Booster Pump #1 at Tower Hill; and

**WHEREAS**, this is a "Force Account" type contract and quantities listed in the proposal are provided as a basis for awarding the contract but no guarantee is made on the final quantity of work to be performed in any given year.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Red Bank that the bid submitted by Layne Christensen Inc. is hereby renewed for Year Three; and

**BE IT FURTHER RESOLVED** that award of this contract is contingent upon approval by and compliance with any and all applicable regulations and requirements of the State of New Jersey and/or the United States of America, or any of their agencies, to the extent any such approval or compliance is applicable;

**BE IT FURTHER RESOLVED** that the Mayor and Clerk are authorized and requested to sign and deliver these contracts on behalf of the Borough of Red Bank;

**BE IT FURTHER RESOLVED** that the Clerk forward a certified true copy of this resolution to Layne Christensen Inc., 719 Mt. Holly Road, Beverly, NJ 08010 and to all unsuccessful bidders.
