**RESOLUTION NO. 14-76**

**A RESOLUTION FIXING FEES AND CHARGES  
UNDER CHAPTER XVIII "PARKS AND RECREATION"  
SECTION 18-6 "FEES AND CHARGES" OF THE  
REVISED GENERAL ORDINANCES**

Councilwoman Lewis offered the following resolution and moved its adoption:

**WHEREAS**, pursuant to Chapter XVII "Parks and Recreation", Section 18-6 "Fees and Charges", it is appropriate that the Governing Body from time to time establish the fees and charges to be collected pertaining to parks and recreation activities.

**NOW, THEREFORE, BE IT RESOLVED** by the Governing Body of the Borough of Red Bank that the facility rental fees for any Borough owned property for the purposes of holding a special event (approved by Council and the Special Events Committee) will be billed at a rate of \$500 per day (sponsored by in town organizations) and \$750 per day sponsored by out of town organizations. Other fees may apply (DPW, Police, etc.)

**BE IT FURTHER RESOLVED** that Borough owned properties include but are not limited to The Count Basie Field Complex, Marine Park, Riverside Garden Park, The White Street Parking Lot, Maple Cove, and The Senior Center.

**BE IT FURTHER RESOLVED** That fees must be paid in advance of all special events.

**BE IT FURTHER RESOLVED** that the fees for all special events facility rentals shall go to the Parks and Recreation Trust to be used for Recreation Programming.

**BE IT FURTHER RESOLVED** that the use of athletic fields for individual sports teams shall be billed on an hourly basis. The use of the turf athletic field shall be billed as followed:

In Town Teams:	
Turf Field Use	\$ 25.00 per hour/2 hour minimum (\$50) \$ 25.00 for each additional hour
Lights Use	\$ 25.00 per hour/2 hour minimum (\$50)
Out of Town Teams:	
Turf Field Use	\$ 50.00 per hour/2 hour minimum (\$100) \$ 50.00 for each additional hour
Lights Use	\$ 35.00 per hour/2 hour minimum (\$70)

**BE IT FURTHER RESOLVED** that an in-town team shall be defined as any team whose roster consists of a minimum of 75 percent Red Bank residents.

**BE IT FURTHER RESOLVED** The Borough of Red Bank, its Department of Parks and Recreation, and the Red Bank Public Schools may use the fields or sponsor a special event without being charged a fee. If The Borough of Red Bank, its Department of Parks and Recreation, and the Red Bank Public Schools sponsor or co sponsor a team/event in town rates may apply.

**BE IT FURTHER RESOLVED** that the within fees and charges shall go to the Parks and Recreation Trust to be used for Recreation Programming and shall be effective immediately.

**BE IT FURTHER RESOLVED** that the Clerk forward a certified true copy of this resolution to the Department of Parks and Recreation.
