RESOLUTION NO. 14-139

A RESOLUTION AMENDING RESOLUTION NO. 13-230 ENTITLED, "A RESOLUTION REQUESTING SPECIAL ITEM OF REVENUE – NEW JERSEY DRUNK DRIVING ENFORCEMENT FUND"

Councilman DuPont offered the following resolution and moved its adoption:

WHEREAS, Resolution No. 13-230 was adopted on October 9, 2013 and indicated the incorrect revenue title to be offset; and

WHEREAS, on the direction of the Borough Auditor a correction is deemed necessary at this time so that the correct revenue title is offset; and

WHEREAS, Resolution No. 13-230 is hereby amended as follows (strikeouts denote deletions, underlined text denote additions):

WHEREAS, N.J.S. 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any county or municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget; and

WHEREAS, said Director may also approve the insertion of any item of appropriation for an equal amount; and

WHEREAS, the Mayor and Council of the Borough of Red Bank will receive funding and wishes to accept funding from the **Department of Law and Public Safety – ~~Division of Highway Traffic Safety~~ Cops in Shops** in the amount of **\$3,200.00** and wish to amend its 2013 budget in the sum of **\$3,200.00** which is now available as a revenue from:

Special Items of General Revenue Anticipated with Prior Written Consent of the Director of Local Government Services:

Public & Private Revenues Offset with Appropriations:

~~**Drunk Driving Enforcement Fund**~~ **Cops in Shops** - Police pursuant to provisions of Statute.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Red Bank that a like sum of **\$3,200.00** be and it is hereby appropriated and accepted under the caption of:
