**WHEREAS**, the plaintiff, 64-68 White Street, Ltd, appealed to the Tax Court of the State of New Jersey under Docket Nos. 009544-2011, 003674-2012, 001976-2013, and 003220-2014 pertaining to tax assessments for the 2011, 2012, 2013 and 2014 tax years on property designated on the municipal tax records as Block 30, Lot 49.01 and commonly known as 64-68 White Street, Red Bank, New Jersey; and
