**RESOLUTION OF THE BOROUGH COUNCIL OF THE  
BOROUGH OF RED BANK, COUNTY OF MONMOUTH, NEW  
JERSEY AUTHORIZING THE PREPARATION AND  
SUBMISSION OF AN APPLICATION TO THE LOCAL FINANCE  
BOARD PURSUANT TO N.J.S.A. 40A:2-51 ET. SEQ.**

**BACKGROUND**

Councilman Murphy offered the following resolution and moved its adoption:

**WHEREAS**, the Borough of Red Bank, County of Monmouth, New Jersey ("Borough"), desires to make application to the Local Finance Board seeking its approval for the adoption by the Borough of a refunding bond ordinance authorizing the issuance of general obligation tax refunding bonds and/or notes of the Borough in the amount of \$675,000; and

**WHEREAS**, the Borough believes:

- (a) it is in the public interest to accomplish such purpose;
- (b) said purpose or improvements are for health, welfare, convenience or betterment of the inhabitants of the Borough;
- (c) the amounts to be expended for said purpose or improvements are not unreasonable or exorbitant; and
- (d) the proposal is an efficient and feasible means of providing services for the needs of the inhabitants of the Borough and will not create an undue financial burden to be placed upon the Borough.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOROUGH COUNCIL OF THE  
BOROUGH OF RED BANK, COUNTY OF MONMOUTH, NEW JERSEY, AS FOLLOWS:**

**Section 1.** The application to the Local Finance Board is hereby approved, and the Borough's Bond Counsel, Solicitor and Auditor, along with other representatives of the Borough, are hereby authorized to prepare such application and to represent the Borough in matters pertaining thereto.

**Section 2.** A copy of this resolution shall be prepared and filed with the Local Finance Board as part of such application.

**Section 3.** The Local Finance Board is hereby respectfully requested to consider such application and to record its findings, recommendations and/or approvals as provided by the applicable New Jersey law.
