RESOLUTION AUTHORIZING AND APPROVING
COLLECTIVE NEGOTIATION AGREEMENT BETWEEN
THE BOROUGH OF RED BANK AND C.W.A. LOCAL #1075
BLUE COLLAR & WHITE COLLAR/CLERICAL EMPLOYEES
FOR THE YEARS 2014 THROUGH 2016

Councilman DuPont offered the following resolution and moved its adoption:

WHEREAS, the existing collective negotiation agreement between C.W.A. Communication Works of America Local 1075 (Local 1075) and the Borough of Red Bank (the Borough) had expired by its terms on December 31, 2013; and

WHEREAS, the Borough and Local 1075 have engaged in good faith negotiations on the terms of a new agreement between the Borough and Local 1075; and

WHEREAS, subject to the approval of the Borough Council, the Borough and Local 1075 have agreed upon the terms and conditions of a new collective negotiation agreement for the term commencing January 1, 2014 through December 31, 2016, as evidenced by a Memorandum of Agreement between the parties; and

WHEREAS, the Mayor and Council of the Borough of Red Bank find that it is in the best interests of the Borough to approve and enter into the agreement as negotiated and agreed to by the parties.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Red Bank that it does hereby authorize and approve the agreement negotiated between Local 1075 and the Borough, which agreement shall be in effect for the years 2014 through 2016.

BE IT FURTHER RESOLVED that the Administrator is authorized and requested to sign the Memorandum of Agreement on behalf of the Borough pending the execution of new collective negotiations agreement, and the Administrator is further authorized and requested to sign the collective negotiations agreement on behalf of the Borough.

BE IT FURTHER RESOLVED that the Clerk forward a certified true copy of this resolution to the Administrator and all Department heads and to the President of the CWA 1075.
