**RESOLUTION NO. 13-34**

**A RESOLUTION AUTHORIZING CERTAIN BOROUGH BUSINESSES TO  
PROVIDE VALET PARKING SERVICES ON BROAD STREET**

Mr. DuPont offered the following resolution and moved its adoption:

**WHEREAS** the Red Bank River Center has requested that Valet Parking services be permitted in a designated location on Broad Street; and

**WHEREAS** representatives of the River Center have consulted with Red Bank Police Department and other Borough officials regarding its proposed plan to provide Valet Parking Services, which plan has been approved by the Police Department on the terms and conditions set forth herein; and

**WHEREAS** the Mayor and Council find that the provision of Valet Parking services on Broad Street during the evening hours is in the best interest of the Borough and beneficial to visitors to the Borough and the merchants located in and around Broad Street;

**NOW, BE IT RESOLVED** by the Governing Body of the Borough of Red Bank that Red Bank River Center businesses are hereby authorized and permitted to provide Valet Parking Services on a trial basis subject to the following conditions and requirements:

1. Location of Valet Service: On the east side of Broad Street beginning at the Northeast corner of Mechanic Street and extending to a point 147 feet north therefrom; and on the east side of Broad Street beginning from the southeast corner of Mechanic Street and extending to a point 95 feet south therefrom;
2. Dates and Times: Daily from 5:00 pm to 2:00 am;
3. Signage: The contracted valet company shall be permitted to place temporary signage at or near the Valet Parking area during the hours of operation to identify the availability of the valet service, subject to the review and approval of the Governing Body or other appropriate Borough officials;
4. Operation of Service: The use of the designated spaces for the Valet Service is limited to Valet Parking Services sponsored and provided by Red Bank River Center businesses;
5. Parking of Vehicles: Vehicles to be parked by the Valet Service are required to be parked in the Mechanic Street municipal parking lot;
6. Exclusive Use by Valet Service During Hours of Operation: During the hours of operation of the Valet Service, no other vehicles shall be permitted to park in or otherwise occupy the designated area for the Valet Service. Except for the authorized hours of operation of the Valet Service, spaces reserved for the Valet Parking service shall be available for use by the general public in accordance with posted signs and applicable parking regulations;
7. Trial Basis: The Valet Parking Services provided by the River Center shall be on a trial basis only, with said authorization to conduct such services to expire on December 31, 2013.

**BE IT FURTHER RESOLVED** that a copy of this Resolution be provided to the Borough Clerk, Red Bank Police Department and the Red Bank RiverCenter.
