RESOLUTION NO. 13-67

A RESOLUTION AWARDING CONTRACT #13-01 ELECTRICAL SERVICES

Mr. Zipprich offered the following resolution and moved its adoption:

WHEREAS, on Wednesday, February 27th, 2013, the Borough of Red Bank received three (3) bids for electrical services; and

WHEREAS, Electro Maintenance, Inc., 5133 W. Hurley Pond Road, Building #3, Farmingdale, NJ 07727, submitted the lowest responsible bid in the amount of \$84.00 per hour and \$126.00 per hour for overtime; and

WHEREAS, the Purchasing Agent has found the paperwork to be in order and Gary Watson, Director of Public Utilities recommends award to the lowest responsible bidder, Electro Maintenance, Inc., 5133 W. Hurley Pond Road, Building #3, Farmingdale, NJ 07727; and

WHEREAS, this is an open-end contract to be used on an as needed basis for two (2) years beginning April 1, 2013 through March 31st, 2015 and all multi-year contracts entered into for a period in excess of twelve months shall be certified and charged to respective budgets in accordance with the times at which the respective work or services are performed or liability for payment is otherwise incurred. Accordingly, commitments and payments required in excess of the initial twelve months are contingent upon necessary funds being appropriated in future budgets by a subsequent body; and

WHEREAS, Electro Maintenance, Inc. has agreed to extend this contract an additional two years for a total of four (4) years if the Borough is satisfied with its performance, and according to NJSA 40A:11-15, any price change included as part of an extension shall not exceed the change in the index rate for the 12 months preceding the most recent quarterly calculation available at the time the contract is renewed;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Red Bank that the contract for the Electrical Services for the Borough of Red Bank be and same is hereby awarded to Electro Maintenance, Inc. 5133 W. Hurley Pond Road, Building 3, Farmingdale, NJ 07727 in the amount of \$84.00 per hour and \$126.00 per hour for overtime starting April 1, 2013 through March 31, 2013 with subsequent renewal as per NJSA 40A:11-15;

BE IT FURTHER RESOLVED that the Mayor and Clerk are requested and authorized to sign and deliver a contract on behalf of the Borough of Red Bank;

BE IT FURTHER RESOLVED that the Borough Clerk forward a certified copy of this resolution to the Purchasing Agent to send with contracts to Electro Maintenance, Inc. and the Department of Public Utilities.
