**RESOLUTION NO. 12-71**

**A RESOLUTION CALLING FOR ACTION BY THE NEW JERSEY LEGISLATURE  
TO ALLOW FULL MARRIAGE EQUALITY FOR  
SAME SEX COUPLES IN NEW JERSEY**

Mr. Zipprich offered the following resolution and moved its adoption:

**WHEREAS**, The Borough of Red Bank is strongly committed to the principle of nondiscrimination on the basis of sexual orientation and to the fair and equitable treatment of all; and

**WHEREAS**, thousands of residents of the state of New Jersey have built strong, lasting, loving relationships that are nonetheless unrecognized by state and federal marriage laws; and

**WHEREAS**, current state and federal marriage laws put a real and unequal burden on many citizens of the Borough of Red Bank; and

**WHEREAS**, the New Jersey Supreme Court presented a unanimous ruling that it is unconstitutional to give same-sex couples lesser rights than different-sex couples; and

**WHEREAS**, in response to that ruling the New Jersey Legislature hastily enacted a civil union law which required review after one year; and

**WHEREAS**, the Civil Union Review Commission, appointed by the New Jersey legislature, issued its report documenting how civil unions fall short of the court-mandated equality for same-sex couples; and

**WHEREAS**, on February 13, 2012 the New Jersey Senate passed marriage equality by a vote of 24 in favor to 16 in opposition; and

**WHEREAS**, on February 16, 2012 the New Jersey Assembly passed marriage equality by a vote of 42 in favor to 33 in opposition; and

**WHEREAS**, on February 17 2012 the Governor of New Jersey vetoed the marriage equality law passed by both the New Jersey Senate and New Jersey Assembly;

**NOW THEREFORE BE IT RESOLVED** that the Mayor and Council of the Borough of Red Bank encourage immediate action by the New Jersey State Legislature to allow full marriage equality to same-sex couples in the State of New Jersey.

**BE IT FURTHER RESOLVED** that a copy of this resolution shall be forwarded to the Borough of Red Bank's representatives in the New Jersey State Assembly and Senate, Governor Christie, the New Jersey League of Municipalities, and the New Jersey Conference of Mayors.
