RESOLUTION NO. 13-103

**RESOLUTION AUTHORIZING EMERGENCY APPROPRIATIONS
IN THE 2013 TEMPORARY BUDGET**

Mr. DuPont offered the following resolution and moved its adoption:

WHEREAS, in accordance with the provisions of N.J.S.A. 40A:4-20 entitled,

EMERGENCY TEMPORARY APPROPRIATIONS:

In addition to temporary appropriations necessary for the period prior to the adoption of the budget and regular appropriations, the governing body may, by resolution adopted by a two-thirds vote of the full membership thereof, make emergency temporary appropriations for any purposes for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year. The amount of such emergency temporary appropriations shall be included under the correct headings in the budget as adopted. If they are adopted after the introduction and approval of the budget and were not included in the budget as approved, they shall be included by amendment in the budget as adopted, except that no public advertisement or public hearings shall be required as to their adoption as amendments.

A copy of each resolution making such emergency temporary appropriations shall be filed forthwith with the director.

WHEREAS, the total aggregate 2013 Emergency Temporary Appropriations that are in compliance with the above referenced statute accumulate to:
