**RESOLUTION NO. 13-149**

**A RESOLUTION RENEWING CONTRACT RELATED TO THE BOROUGH'S  
WATER AND SEWER CONNECTIONS AND MAINS FORCE ACCOUNT**

Mr. DuPont offered the following resolution and moved its adoption:

**WHEREAS**, on May 2, 2012, sealed bids were received for certain work related to the Borough's Water and Sewer Connections and Mains Force Account for the period between June 1, 2012 and May 31 2013, with an optional renewal period of June 1, 2013 through May 31, 2014 at a unit cost bid price not to exceed \$272,129.89 for each year; and

**WHEREAS**, Resolution No. 12-101 awarded the contract to Mark Woszczak Mechanical Contractors, Inc. at a unit cost bid price not to exceed \$272,129.89; and

**WHEREAS**, the first year term of the contract has expired and the Borough Engineer has recommended that the contract be renewed for the period of June 1, 2013 to May 31, 2014 at a unit cost bid price not to exceed \$272,129.89; and

**WHEREAS**, funds are available for this purpose as certified by the Chief Financial Officer as demonstrated by the attached certification in account no(s). 3-05-55-501-259.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Red Bank that the above described contract with Mark Woszczak Mechanical Contractors, Inc. is hereby renewed for a term of June 1, 2013 to May 31, 2014 at a unit cost bid price not to exceed \$272,129.89.

**BE IT FURTHER RESOLVED** that the Mayor and Clerk are authorized and requested to sign and deliver this contract on behalf of the Borough of Red Bank.

**BE IT FURTHER RESOLVED** that no extensions to this contract shall be granted without further approval of the Borough Council.
