WHEREAS, Robert has also served with distinction as 2nd Lieutenant, 1st Lieutenant, Captain, Vice President and President of the Red Bank Fire Police, as a delegate to the Red Bank Fire Department's Executive Council, as a delegate to the Red Bank Fireman's Relief Association, a member of the Board of visitor's, a member of the Red Bank Exempt Firemen's Association and is a Life member of the New Jersey State Firemen's Association; and

WHEREAS, Mr. Laveratt, during his fifty years of service has served on numerous committees of the Navesink Hook and Ladder Company and the Red Bank Fire Department and remains an active member of the department.

WHEREAS, throughout all of his years of service, he has won the admiration and the respect of his fellow citizens and has been sustained by the love and support of his Friends and family.
