**RESOLUTION TO AUTHORIZE SHARED SERVICES AGREEMENT BETWEEN THE  
BOROUGH OF TINTON FALLS THE BOROUGH OF RED BANK  
FOR SHARED USE OF TRUCK WASH FACILITY**

Mr. DuPont offered the following resolution and moved its adoption:

**WHEREAS**, the New Jersey Uniform Shared Services and Consolidation Act (N.J.S.A. 40A:65A-1, et seq.) authorizes joint activities among municipalities and was enacted with the intent to facilitate and promote Share Services agreements; and

**WHEREAS**, the NJDEP regulations require municipalities to maintain or utilize specialized truck wash facilities to eliminate stormwater runoff from municipal waste and debris contained on certain municipal vehicles, which the Borough of Tinton Falls has in place within its' Public Works Department; and

**WHEREAS**, the Borough of Tinton Falls has offered to enter into a Shared Services agreement with the Borough of Red Bank whereas the Borough of Tinton Falls will wash tandem trucks, sanitation trucks and similar trucks for \$25.00 per wash and single axle trucks, front end wheel loaders and similar vehicles for \$20.00 per wash; and

**WHEREAS**, it is in the best interest of the Borough of Red Bank to into enter the proposed Agreement with the Borough of Tinton Falls.

**NOW, THEREFORE, BE IT RESOLVED** by the Governing Body of the Borough of Red Bank that the Mayor and Municipal Clerk be and they are hereby authorized to execute the attached Shared Services Agreement with the Borough of Eatontown for a period of two (2) years through 2015.

**BE IT FURTHER RESOLVED** that the Municipal Clerk forward a certified copy of this resolution, along with the executed Shared Services Agreement to the Borough Clerk of the Borough of Tinton Falls, 556 Tinton Avenue, Tinton Falls, New Jersey 07724.

**BE IT FURTHER RESOLVED** that the Agreement shall be subject to review and approval by the Borough Attorney.
