**A RESOLUTION AUTHORIZING THE MAYOR TO SIGN A CERTIFICATION
PROHIBITING THE USE OF EXCESSIVE FORCE AND A CERTIFICATON
PROHIBITING THE USE OF FEDERAL FUNDS FOR LOBBYING**

Mr. Murphy offered the following resolution and moved its adoption:

WHEREAS, certain federal funds are potentially available to Monmouth County through the Housing and Community Development Act of 1974, as amended; and

WHEREAS, the United States Department of Housing and Urban Development has allocated funding to the County of Monmouth for FY 2012; and

WHEREAS, the County is making some of these funds available to certain participating municipalities and non-profit agencies; and

WHEREAS, it is required that the Borough of Red Bank execute a project agreement with Monmouth County to undertake a project known as Count Basie Park Restroom Improvements; and

WHEREAS, the US Department of Housing and Urban Development is requiring that the Mayor of the Borough of Red Bank sign additional certifications in order to receive these funds; and

WHEREAS, the Borough of Red Bank has adopted a policy prohibiting the use of excessive force by its law enforcement agency (policy force) within its jurisdiction against any individuals engaged in non-violent civil rights demonstrations; and

WHEREAS, a copy of that policy is attached to and made part of this resolution.

NOW, THEREFORE, BE IT RESOLVED that the Borough of Red Bank has met the conditions of receiving a FY 2012 allocation by adopting a policy prohibiting the use of excessive force and by not using federal funds for lobbying or by disclosing that funds has been used for lobbying.

BE IT FURTHER RESOLVED that the Mayor of the Borough of Red Bank is authorized to sign the attached certifications which will be part of the FY 2012 Project Agreement.

Red Bank Police Department's Use of Force Policy U-2, which was issued on 3/1/2005.

PURPOSE

To set proper guidelines for members of the Red Bank Police Department to follow when they have to use force while completing an assignment.

POLICY

It is the policy of the Red Bank Police Department that police officers will use only that force which is objectively reasonable and necessary. This policy reinforces the responsibility of law enforcement officers to take those steps possible to prevent or stop the illegal or inappropriate use of force by other officers. Every law enforcement officer is expected and required to take appropriate action in any situation where that officer is clearly convinced that another officer is using force in violation of state law. Law enforcement officers are obligated to report all situations in which force is used illegally by anyone.
