**RESOLUTION NO. 12-190**

**A RESOLUTION CREATING THE BOROUGH OF RED BANK  
COMMUNITY GARDEN AD HOC COMMITTEE**

Ms. Horgan offered the following resolution and moved its adoption:

**WHEREAS**, residents of the Borough of Red Bank have expressed an interest in creating a Community Garden within the Borough; and

**WHEREAS**, the Mayor and Council have agreed that this endeavor would benefit the community and have given their approval for the formation of an Ad Hoc Committee for this purpose; and

**WHEREAS**, forming an Ad Hoc Committee was the solution for the 2012 calendar year in the interest of time until a formal ordinance can be introduced and adopted for the formation of the Red Bank Community Garden Committee; and

**WHEREAS**, the Mayor with the advice and consent of Council has appointed the following members to the Red Bank Community Garden Ad Hoc Committee for 2012:

Elizabeth Seydell, 158 Chestnut Street

Kenton Seydell, 158 Chestnut Street

**WHEREAS**, the Mayor with the advice and consent of the Council hereby appoints Elizabeth Seydell as the Chairperson/Coordinator of Red Bank Community Garden Committee for 2012; and

**WHEREAS**, the Chairperson/Coordinator shall be the liaison between the Borough and Community Garden Ad Hoc Committee and shall report directly to the Borough Administrator regarding any and all activities of the Community Garden that require Borough approval or that will involve expenditures by the Borough. No such activities or expenditures shall be undertaken without first obtaining the Administrator's approval, or where necessary the approval or the Mayor and Council; and

**WHEREAS**, the Community Garden Committee shall establish rules and procedures for the use of the Community Garden, including, but not limited to application forms, hold harmless agreements and a fee schedule for annual use, all of which are subject to approval by the Administrator, or where necessary by the Mayor and Council; and

**WHEREAS**, all fees received from Community Garden applicants/users will be deposited as a separate line item in the Borough's Recreation Trust account to be used to pay for any expenses associated with the establishment, operation and maintenance of the Community Garden; and

**NOW, THEREFORE, BE IT RESOLVED** that the Red Bank Community Garden Ad Hoc Committee is hereby established for the year 2012.
