**RESOLUTION SUPPORTING THE COUNTY OF MONMOUTH  
CONSTRUCTION OF IMPROVEMENTS TO COUNTY ROUTE 10  
(FRONT /EAST FRONT STREET) BETWEEN ENGLISH PLAZA AND  
WASHINGTON STREET IN THE BOROUGH OF RED BANK**

Mr. Murphy offered the following resolution and moved its adoption:

**WHEREAS**, Riverview Hospital petitioned to the County and the Borough of Red Bank to upgrade traffic control devices at the crosswalk across County Route 10 (Front/East Front St) at the Hospital Drive to enhance pedestrian safety; and

**WHEREAS**, the County of Monmouth and the Borough of Red Bank agree that the need exists for enhancement of the existing crosswalk and other pedestrian facilities along the County Route 10 corridor between English Plaza and Washington Street; and

**WHEREAS**, the County of Monmouth has proposed a plan for the improvements to the County Route 10 corridor between English Plaza and Washington Street to enhance pedestrian and vehicular safety; and

**WHEREAS**, enhancement elements consist of providing uniform width of the roadway with traffic calming features such as bulb outs, color crosswalks and color medians within the corridor, reconstruction of the existing sidewalks and other pedestrian facilities including installation of pedestrian flashing beacons at the Riverview Hospital crosswalks, upgrade of the existing traffic signal at County Route 10 and Globe Place, construction of a raised intersection at the County Route 10 and Broad Street intersection, and spot drainage improvements within the corridor; and

**WHEREAS**, the County of Monmouth obtained a grant in the amount of \$500,000.00 for construction of these improvements; and

**WHEREAS**, it is a desire of the Mayor and the Council of the Borough of Red Bank to support the above described improvements along the County Route 10 corridor proposed by the County of Monmouth.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Red Bank that they hereby call upon the County of Monmouth to construct the subject improvements along the County Route 10 (Front/East Front St) corridor between English Plaza and Washington Street.
