**A RESOLUTION RELEASING MAINTENANCE BOND POSTED BY  
SRA, L.L.C. (a/k/a Red Bank Corporate Plaza, L.L.C.), WEST FRONT AND PEARL  
STREETS, BLOCK 34, LOTS 3,4, 5.01, 17, 20, 21, 22, 23 AND 24**

Mr. DuPont offered the following resolution and moved its adoption:

**WHEREAS**, on July 28, 2008, under Resolution No. 08-153, the Borough of Red Bank (the “Borough”) accepted Maintenance Bond No. 105124006, issued by the Travelers Casualty and Surety Company of America, in the sum of \$72,025.50 posted by SRA, L.L.C. (a/k/a Red Bank Corporate Plaza, L.L.C.), (the “Developer”) in connection with a project located at West Front and Peal Streets, Block 34, Lots 3, 4, 5.01, 17, 20, 21, 22, 23 and 24; and

**WHEREAS**, the Developer has requested that the Borough release the aforementioned maintenance bond; and

**WHEREAS**, the Borough Engineer completed a maintenance bond inspection of the subject property and found that all outstanding have been addressed; and

**WHEREAS**, the release of the aforementioned performance bond is in accordance with the Borough Engineer's report and recommendations concerning this project, dated June 16, 2011;

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Red Bank as follows:

- a. Maintenance Bond No. 105124006, issued by the Travelers Casualty and Surety Company of America, in the sum of \$72, 025.50 shall be released; and

**BE IT FURTHER RESOLVED** that the Chief Financial Officer and the Director of Planning and Zoning are authorized and requested to take appropriate steps to implement this resolution; and

**BE IT FURTHER RESOLVED** that the Borough Clerk shall forward certified true copies of this resolution to the Borough Engineer, the Director of Planning and Zoning, the Chief Financial Officer and to SRA, L.L.C. (a/k/a Red Bank Corporate Plaza, L.L.C.), 343 Thornall Street, Edison, New Jersey.
