

ORDINANCE 2018-24

ORDINANCE OF THE BOROUGH OF RED BANK, COUNTY OF MONMOUTH, STATE OF  
NEW JERSEY AMENDING AND SUPPLEMENTING CHAPTER 490, PLANNING AND  
DEVELOPMENT REGULATIONS, RELATING TO TATTOO ESTABLISHMENTS

Councilman Yngstrom offered a motion to adopt the following ordinance:

**WHEREAS**, the following amendments to the Land Development Ordinance would allow tattoo establishments in certain zones within the Borough;

**NOW, THEREFORE BE IT ORDAINED**, by the Borough Council of the Borough of Red Bank that Chapter 490 of the Revised General Ordinances is hereby amended in the following manner:

§ 490-142A(4)(b) prohibiting tattoo parlors in the NB zone shall be deleted in its entirety.

§ 490-144A(4)(b) prohibiting tattoo parlors in the CCD-1 zone shall be deleted in its entirety.

§ 490-145A(4)(b) prohibiting tattoo parlors in the CCD-2 zone shall be deleted in its entirety.

§ 490-146A(7)(b) prohibiting tattoo parlors in the BR-1 zone shall be deleted in its entirety.

§ 490-151A(9)(b) prohibiting tattoo parlors in the BR-2 zone shall be deleted in its entirety.

**BE IT FURTHER ORDAINED**, that a copy of this Ordinance, upon introduction, shall be provided to all appropriate municipal agencies, including the Planning Board, for their review and comment pursuant to applicable New Jersey Statutes.

**BE IT FURTHER ORDAINED** that any ordinances or portions thereof which are inconsistent with the provisions of this Ordinance are hereby repealed as of the effective date of this Ordinance. All other provisions of the Revised General Ordinances are ratified and remain in full force and effect.

**BE IT FURTHER ORDAINED** that, if any provision of this Ordinance or the application of such provision to any person or circumstance is declared invalid, such invalidity shall not affect the other provisions or applications of this Ordinance which can be given effect, and to this end, the provisions of this Ordinance are declared to be severable.

**BE IT FURTHER ORDAINED** that this Ordinance shall take effect immediately upon its passage and adoption according to law.
