**RESOLUTION AMENDING RESOLUTION NO. 17-296 TO CORRECTLY REFLECT THE
PREVIOUSLY ADVERTISED AND DULY AWARDED THREE-YEAR CONTRACT
TO ALERT AMBULANCE SERVICE, INC. FOR EMERGENCY MEDICAL SERVICES**

Councilman Yngstrom offered the following resolution and moved its adoption:

WHEREAS, the Borough of Red Bank previously sought proposals and duly awarded a contract for Emergency Medical Services to Alert Ambulance Service, Inc. for a contract period of three years by Resolution No. 17-296, dated December 27, 2017; and

WHEREAS, pursuant to an EMS Agreement, dated January 1, 2018, with a term from January 1, 2018 to December 31, 2020, Alert Ambulance Service, Inc. presently provides Emergency Medical Services to the Borough on a 7 day a week/24 hour basis in the amount of \$120,000 per year; and

WHEREAS, it has come to Borough's attention that Resolution No. 17-296 contained two typographical errors, whereby the appropriate three-year term of the contract awarded to Alert Ambulance Service, Inc. was not set forth in said Resolution; and

WHEREAS, the Chief Financial Officer requires that Resolution No. 17-296 be corrected to authorize the continuation of payments to Alert Ambulance Service, Inc. under its EMS Agreement, dated January 1, 2018; and

WHEREAS, the Chief Financial Officer certified that sufficient funds are available for this contract.

NOW, THEREFORE, BE IT RESOLVED by the Mayor & Council of the Borough of Red Bank that its prior Resolution No. 17-296 is amended to reflect that Alert Ambulance Service, Inc. was awarded a contract for Emergency Medical Services from January 1, 2018 through December 31, 2020 in the amount of \$10,000 per month not to exceed \$120,000 per year.
