**A RESOLUTION AWARDING A CONTRACT PURSUANT TO THE LOCAL PUBLIC
CONTRACTS LAW TO LUCAS CONSTRUCTION GROUP, INC., RED BANK, NEW
JERSEY, FOR RED BANK PRIMARY SCHOOL EMERGENCY ACCESS DRIVEWAY**

WHEREAS, the Borough of Red Bank advertised for bids for a public improvements project known as the Red Bank Primary School Emergency Access Driveway; and

WHEREAS, on March 7, 2019, the Borough of Red Bank received bids for construction of the Emergency Access Road Improvements as follows:

(1) Lucas Construction Group, Inc	\$878,878.00
(2) Precise Construction, Inc.	\$894,150.00; and

WHEREAS, pursuant to the Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq., and upon recommendation of Christine A. Ballard, P.E. Consulting Engineer, Lucas Construction Group, Inc. has been determined to be the lowest responsible bidder,

NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the Borough of Red Bank that a contract is hereby awarded to Lucas Construction Group, Inc, Red Bank, New Jersey, in the amount of \$878,878.00 for the Primary School Emergency Access Driveway Improvements, to be completed within one hundred working days from the Notice to Proceed, and that the Mayor and the Clerk of the Borough of Red Bank are authorized to execute and attest to an agreement with Lucas Construction Group, Inc., Red Bank, New Jersey, pursuant to bid specifications, and in a form approved by the Borough Attorney; and

BE IT FURTHER RESOLVED, that the Borough Clerk shall publish a notice of this action in the official newspaper of the Borough within 10 days from the adoption of this Resolution; and

BE IT FURTHER RESOLVED, the account to be charged is C-04-15-008-498 in an amount not to exceed \$878,878.00 and that the Chief Financial Officer has issued a Certificate of Available Funds which is incorporated herein by reference.
