**A RESOLUTION AUTHORIZING CONTRACT MODIFICATION #1 TO A PROFESSIONAL SERVICES CONTRACT WITH T&M ASSOCIATES FOR ENGINEERING SERVICES TO INCLUDE ROADWAY RECONSTRUCTION FOR PEARL STREET IMPROVEMENTS**

**WHEREAS**, a professional services contract was awarded to T&M Associates by Resolution 19-43 for Engineering Services for Pearl Street Improvements; and

**WHEREAS**, subsequent to the award of a Professional Services Contract, a certified testing lab obtained pavement cores on Pearl Street and determined that there is general less than 2 ½” of asphalt between Water Street and Chestnut Street; and

**WHEREAS**, Consulting Engineer Christine Ballard, P.E., of T&M Associates believes that these three blocks are unsuitable for milling and resurfacing and recommends that the two blocks between Chestnut Street and Monmouth Street should be reconstructed; and

**WHEREAS**, there are additional costs necessary to complete the design, obtain field survey, prepare more detailed grading plans, prepare Soil Erosion and Sediment Control certification plans, and provide inspections for additional work days; and

**WHEREAS**, T&M Associates has provided a Contract Modification proposal dated March 26, 2019 to perform these additional services for an amount of \$28,220.

**NOW, THEREFORE, BE IT RESOLVED** by the Governing Body of the Borough of Red Bank that it hereby authorizes a contract modification to the original professional services contract for T&M Associates for professional engineering services for additional work outside the original scope of the project for the Pearl Street Improvements at an additional fee not to exceed \$28,220.00, pursuant to a proposal dated March 26, 2019. This contract is awarded without competitive bids as a “professional services contract” in accordance with N.J.S.A. 40A:11-5 (1)(a)(I) of the Local Public Contract Law.

**BE IT FURTHER RESOLVED**, that the account to be charged is C-04-18-033-398 in an amount not to exceed \$74,210.00 and that the Chief Financial Officer has issued a Certificate of Available Funds which is incorporated herein by reference.
