**A RESOLUTION ACCEPTING BIDS AND AWARDING CONTRACT  
FOR PEARL STREET IMPROVEMENTS**

**WHEREAS**, on September 4, 2019, bids were received for the Borough’s Pearl Street Improvements, as follows:

**WHEREAS**, the T&M Associates has reviewed the bids received from the aforementioned contractors; and

**WHEREAS**, the T&M Associates has recommended award of the contract to the lowest responsible bidder, Precise Construction, Inc., 1016 Highway 33, Freehold, New Jersey 07728, in the amount of \$445,262.40 for bid items 1 through 40, inclusive, as available funding permits, subject to review by the Borough Attorney; and

**WHEREAS**, the Borough Attorney has reviewed the award and finds same to be legally acceptable and appropriate;

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Red Bank that the above-described bid received from Precise Construction, Inc., 1016 Highway 33, Freehold, New Jersey 07728 for the Borough’s Pearl Street Improvements is hereby accepted in accordance with the recommendation of the T&M Associates and the review of the Borough Attorney.

**BE IT FURTHER RESOLVED** that the Mayor and Clerk are authorized and requested to sign and deliver applicable contract(s) on behalf of the Borough of Red Bank, subject to review by the Borough Attorney, including review of bid bond and surety provided by the low bidder.

**BE IT FURTHER RESOLVED** that the bid and bid securities of the second and third lowest bidders, Black Rock Enterprises and Discover Construction LLC shall be retained and held open, pending execution of the awarded contract by Precise Construction, Inc.

**BE IT FURTHER RESOLVED**, that the account to be charged is C-04-18-033-398 in an amount not to exceed \$445,262.40 and that the Chief Financial Officer has issued a Certificate of Available Funds which is incorporated herein by reference

**BE IT FURTHER RESOLVED** that the Borough Clerk forward a certified true copy of this resolution to the Borough Administrator, Borough CFO, T&M Associates, Precise Construction Inc., and to the unsuccessful bidders.
