**A RESOLUTION AUTHORIZING THE BOROUGH ENGINEER, CME ASSOCIATES, TO PERFORM PROFESSIONAL ENGINEERING SERVICES FOR THE BOROUGH FOR THE 2019-2020 ROAD PROGRAM AT A COST NOT TO EXCEED \$91,000.00**

**WHEREAS**, the Borough of Red Bank, County of Monmouth, State of New Jersey (the "Borough") requires professional engineering services for the design, permitting, and construction administration of its 2019-2020 Road Program (the "Project"); and

**WHEREAS**, at its 2020 Reorganization Meeting, the Borough qualified and appointed a Borough Engineer and several Special Projects Engineers for the purposes of competitively awarding contracts for special projects, such as the Project, throughout the year; and

**WHEREAS**, CME Associates was previously qualified and appointed as the Borough Engineer within the Borough; and

**WHEREAS**, the Borough Administrator received Proposals from four (4) engineering firms to complete the Project; and

**WHEREAS**, CME Associates is experienced in providing the professional engineering services needed for the Project, and provided the Borough with Proposal No. 2020-025 for the Project at a cost of \$91,000.00, which Proposal is the most advantageous to the Borough as to price and time for completion and is attached hereto as Exhibit A;

**NOW, THEREFORE, BE IT RESOLVED**, by the Governing Body of the Borough of Red Bank, County of Monmouth, State of New Jersey as follows:

1. The Borough Engineer, CME Associates, is authorized by the Governing Body to perform professional engineering services as per Proposal No. 2020-025 in an amount not to exceed \$91,000.00, which Proposal is attached as Exhibit A.
2. That the account to be charged is C-04-19-121-398 in an amount not to exceed \$91,000.00 and that the Chief Financial Officer has issued a Certificate of Available Funds which is incorporated herein by reference
3. That a certified copy of this resolution be forwarded to the Chief Financial Officer, the Borough Administrator, the Borough DPU Director, and the Borough Engineer.
