**A RESOLUTION AUTHORIZING SALE OF PERSONAL PROPERTY**

**WHEREAS**, Local Public Contracts Law NJSA 40A:11-36 requires authorization of a sale of said property via adoption of a Resolution; and

**WHEREAS**, the estimated fair market value of the property to be sold does exceed 15% of the bid threshold; and

**WHEREAS**, the attached list of vehicles and other items for sale will be published in the Asbury Park Press no earlier than 14 days nor later than 7 days prior to said auction;

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Red Bank that the Borough be authorized to dispose of the following vehicles and other miscellaneous items through the process of an online auction to be held beginning at 9:00 a.m. on Saturday, May 2, 2009 and ending at 7:00 p.m. on Friday, May 8, 2009 on the website located at govauctionlistservices.com;
