**A RESOLUTION OF APPROVAL TO SUBMIT A GRANT APPLICATION AND EXECUTE A GRANT AGREEMENT WITH THE NEW JERSEY DEPARTMENT OF TRANSPORTATION FOR THE CHESTNUT STREET PHASE II PROJECT**

**WHEREAS**, the New Jersey Department of Transportation (NJDOT) is accepting applications for Municipal Aid projects, and NJDOT will provide financial assistance to municipalities for transportation infrastructure improvements which are selected through the grant application process; and

**WHEREAS**, Chestnut Street is in need of improvement, Therefore, the Borough of Red Bank will submit a Municipal Aid Grant Application for Chestnut Street Phase II project, which will extend from Phase I at the New Jersey Transit railroad tracks to Shrewsbury Avenue (Monmouth County CR-13);

**NOW, THEREFORE, BE IT RESOLVED** that the Council of the Borough of Red Bank, formally approves the grant application for the above stated project;

**BE IT FURTHER RESOLVED** that the Mayor and Clerk are hereby authorized to submit an electronic grant application identified as MA-2010-Red Bank Borough-00832 to the New Jersey Department of Transportation on behalf of the Borough of Red Bank;

**BE IT FURTHER RESOLVED** that the Mayor and Clerk are hereby authorized to sign the grant agreement on behalf of the Borough of Red Bank and that their signature constitutes acceptance of the terms and conditions of the grant agreement and approves the execution of the grant agreement.
